A Federal warrant was issued on August 22, 1983, at the Central District of Tennessee charging Messmer with Racketeer Influenced and Corrupt Organizations (Title 18, U.S. Code, Section 1962); Money Laundering (Title 18, U.S. Code, Section 934); Conspiracy to Import Narcotics (Title 21, U.S. Code, Section 952); Importation of Narcotics (Title 21, U.S. Code, Section 951); Conspiracy to Distribute narcotics (Title 21, U.S. Code, Section 841(a)(1)); Distribution of Narcotics (Title 21, U.S. Code, Section 841 (a)(2)); Use of Telephone in Narcotics Transactions (Title 21, U.S. Code, Section 843); Travel in Foreign or Interstate Commerce to Facilitate Narcotics Transactions (Title 18, U.S. Code, Section 1952); Possession with Intent to Distribute Cocaine (Title 21, U.S. Code, Section 841); Possession of Automatic Weapons (Title 21, U.S. Code, Section 721); Possession of Explosives (Title 21, U.S. Code, Section 720); Continuing Criminal Enterprise Activity (Title 18, U.S. Code, Section 1962(a)); and Interstate Flight to Avoid Prosecution for the aforementioned violations.
